1. SCOPE OF WORK & COMPONENTS

Component	Specification
Light Unit	24 W semi LED integrated solar street light featuring a dimming function from a reputed brand
Battery	12.8 V 18Ah LifePo4 (Uthium Ferro battery)
Solar panel	60 W solar panel from a reputed brand
Structure	GI 18-foot pole with a litted panel mounting structure pipe.
Additional Requirement	Includes branding board, complete wiring, grouting, and a 5 -year warranty.
Execution	The contract includes Supply, Installation, and Commissioning.
Timeline	Installation is expected to take 2-3 days per tank.
Warranty	Minimum 36-month warranty against workmanship and material defects.
Site Requirements	Client will provide foundation (as per provided drawings), 4 local labourers for assistance, and electricity for drilling/cutting.
