Supply of High-capacity Drinking Water Purifier modular storage tanks

Introduction & Scope

Sanjeevani Vikas Evam Jan Kalyan Samiti invites sealed bids from authorized manufacturers, dealers, and engineering suppliers for the procurement and supply of **high-capacity drinking water purifier modular storage tanks**. The delivery site is in Syalde Block, Almora District, Uttarakhand.

Technical Specifications & Scope of Supply

Supplied units must meet strict engineering and structural parameters for potable water storage in Hilly terrains.

Tank Type: Premium Liquid Storage Zinc-Aluminum (Zn-Al) Alloy Coated Steel Tanks (Modular/Bolt-on type).

Capacity: 12,000 Liters per tank unit.

Material Composition: High-tensile steel sheet substrate hot-dip coated with a corrosion-resistant Zinc-Aluminum alloy to withstand extreme open-field weathering.

Internal Liner: Food-grade, UV-stabilized, heavy-duty flexible liner (reinforced PVC/PP) to maintain water quality and prevent chemical leaching or internal algae growth.

Standard Fixtures: Reinforced roof structure with lockable inspection manhole, air vent, high-flow threaded inlet/outlet sockets, brass/SS internal ball-valve float system, scour/washout valve for silt clearing, and clear water-level indicators.

Deliverables Expected

Equipment Supply: Safe transit and delivery of factory-tested modular tank panels, internal liners, and hardware components to designated community clusters in Syalde Block.

Documentation: Handover of detailed layout assembly schematics, maintenance manuals, and official manufacturer warranty cards.

Vendor Criteria

Logistical Competence: Capability to manage safe heavy-transit, hauling, and delivery of panels across remote high-altitude routes in Almora district.

Quality & Warranty: Sourced items must carry standard food-grade material certifications. A minimum 5-year structural and leak-proof warranty on the tank and liner assembly is mandatory.
